County raises high bar in scrutiny of mega dairy proposal

A mega dairy's roller coaster ride to meet all permit conditions to build west of Brodhead mounted another set of challenges this month.

Twists and turns in a course that has plunged and risen for Pinnacle Dairy's proposed 5,800-cow dairy since July 2015 appear still-uncertain. Yet a Green County decision on the proposal could come in April.

Green County issued a nine-page summary review March 2 of land spreading accords, nutrient management plans, manure storage design and dewatering for the proposed site. Problems cited showed county staff still have serious concerns about the proposal.

Legal counsel for the Todd Tuls family, based in Rising City, Neb., assured county staff and elected supervisors the dairy's engineers and crop consultants will "fix" all problems cited.

County Conservationist Todd Jensen, who with Land and Water Conservation staff scrutinized Pinnacle's proposal, said last week that remains to be seen. In a phone interview, Jensen told

the Independent Register he consulted state NRCS and DATCP engineers in his review, and concerns about dewatering the wet site have not abated.

Land and Water Conservation's review identified discrepancies in 17 of 31 easement agreements presented in Pinnacle's land spreading contracts this past December. Confusing ownership, parcel exclusions, extra parcels, missing parcels, inaccurate land descriptions and lacking easement records troubled the proposal.

Pinnacle Dairy's Nutrient Management Plan, which Brian Mooney of the Delong Company wrote for the proposal, also drew three pages of questions in the county review. The number of acres for the plan varies from 7,608 acres in the NMP checklist, to 7,096 acres in the plan's electronic NMP program, to a third difference of another 133 acres off the checklist total by field map comparison.

Jensen's staff identified other problems in the proposed dairy's plan to dispose of 16,364 tons of solid manure and 68 million gallons of liquid manure annually in Green, Rock and Lafayette counties.

Some well and field maps are incomplete or inconsistent. A few fields are short soil samples or missing soil data. Rotations for seven fields include no seeding year. And while the plan indicates tolerable soil loss for all fields, a copy of the plan made in an NMP computer program showed 31 of 108 fields

exceeded erosion limits.

"Manure allocated over the rotation in the plan over-allocated by 5 million gallons 3 out of 4 years," Jensen's report stated. "One year was under-spread by more than 1 million gallons," leaving no strategy for compensating with chemical fertilizer on 560 acres.

Deepest of concerns in the county review, however, are problems with the massive waste containment structures in the proposal on a very wet site in Sylvester Township near Albany and Brodhead. Proposed de-watering of the site drew Jensen's gravest concerns.

"Many of the soil profile descriptions are incomplete and/or internally inconsistent," Jensen stated in his report March 2, citing limited borehole information federal standards require.

Soil colors at the proposed mega dairy building site indicate water saturation of the soil at depths that will be above the bottom of the manure storage facility, Jensen said. Further, "methods offered by the proposal's consultants to support a perched condition (which would be drainable) are not acceptable."

Jensen spelled a half page of steps Green County wants to see taken before the site is excavated for 20 acres of containment structures, cattle barns and livestock facilities to milk and care for the thousands of cows at the site and deal with all of their wastes.

County raises high bar in scrutiny of mega dairy proposal

A mega dairy's roller coaster ride to meet all permit conditions to build west of Brodhead mounted another set of challenges this month.

Twists and turns in a course that has plunged and risen for Pinnacle Dairy's proposed 5,800-cow dairy since July 2015 appear still-uncertain. Yet a Green County decision on the proposal could come in April.

Green County issued a nine-page summary review March 2 of land spreading accords, nutrient management plans, manure storage design and dewatering for the proposed site. Problems cited showed county staff still have serious concerns about the proposal.

Legal counsel for the Todd Tuls family, based in Rising City, Neb., assured county staff and elected supervisors the dairy's engineers and crop consultants will "fix" all problems cited.

County Conservationist Todd Jensen, who with Land and Water Conservation staff scrutinized Pinnacle's proposal, said last week that remains to be seen. In a phone interview, Jensen told

the Independent Register he consulted state NRCS and DATCP engineers in his review, and concerns about dewatering the wet site have not abated.

Land and Water Conservation's review identified discrepancies in 17 of 31 easement agreements presented in Pinnacle's land spreading contracts this past December. Albany Math 24 teams compete

Last week, the fourth-, fifth-, and sixth-grade Math 24 teams competed in the South Region Competition at the Union South in Madison. They competed against teams from Belleville, Evansville, New Glarus, Parkview, and Stoughton.

Math 24 is a fast-paced mathematics program that builds strong mental mathematics and problem-solving skills.

The challenge is to create equations that total 24 by using all numbers on each given card and any combination of addition, subtraction, multiplication, or division.

Fourth-grade competitors use the double-digit cards, fifth-graders use variable cards, and sixth-graders use positive/negative integers.

Students take part in four rounds, in which they can earn first, second or third place. How each student does for the first three rounds decides what table and who he or she competes against in the fourth round.

After all four rounds, awards are given to students in places first through sixth. One student in each school group is also awarded the highest score for their school.

Blake Finley had the most points for Albany fourth graders. Ava Ahnen placed second and had the highest points for the Albany fifth graders. Linsey Mueller placed fifth and had the most points for Albany sixth graders.

The fourth-grade team consisted of Blake Finley, Cody Pryce, and Caleb Smith. This year, fifth grade had two teams that competed; they consisted of Ava Ahnen, Brayden Bakken, Aiden Brewer, Maiya O'Bel, Allison Rhyner, and Cooper S. The sixth-grade team consisted of Ethan Koss, Linsey Mueller, and Peyton Pendergrass.

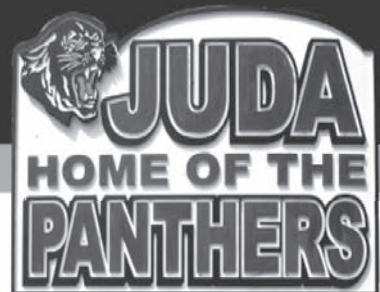
Our club arts festival followed the meeting. Members exhibited over 30 art-related projects. They talked about and shared what they had done.

Green County Board Updates

The Land and Water Conservation Committee meeting on March 2 was standing room only, if you were even able to get in the door. The meeting was packed. There was an update on the proposed Pinnacle Dairy project, discussion on modifying the manure storage ordinance, reports from the departments, an update on the hydro-geological study, and a great water/soil health demonstration.

For me, a highlight of the Land and Water meeting each month is the educational component. There is almost always a demonstration. This

time, it was a demonstration about aquifers, ground water recharge, contamination, and the effect of contamination on wells. It was cleverly done with ice cream, soda, ice, straws, and food coloring.

The visual impact and clarity of the demonstration was such that I recreated it at home for my kids with great success, both educationally and gastronomically.

The committee discussed modifications to the manure storage ordinance, and their recommendations went to the entire county board for a vote at the March 14 meeting.

Robb Sommers, Green County

Land Information Officer, gave a report on the progress of the hydro-geologic survey: it is underway and on schedule.

Todd Jenson, County Conservationist, gave an update on the proposed Pinnacle Dairy's permit status. The proposed factory farm is still awaiting permits from Green County; Jenson and his team found areas of question in the permit applications and have asked for more and clarified information from the corporation.

At the County Board meeting on March 14, the modification to the manure storage ordinance was put forward for a vote, a discussion about

the animal siting ordinance took place, and a presentation demonstrated the progress of the government services building.

You can see what meetings are coming up and the agendas for the meetings at the county website at www.co.green.wi.gov. The upcoming meetings are listed at the lower right side of the main page under the heading "Upcoming Meetings." All county board and committee meetings are open to the public, and you are welcomed to attend.

I was fortunate enough to visit the capitol on Feb. 28 as part of the Wisconsin Farmers Union Farm and Rural Lobby Day. With other concerned residents, I was able to talk with Senator Ringhand and Representative Sprietzer about our roads, water, schools, food, broadband, and farms in our area. It was a productive and inspiring day at the capitol.

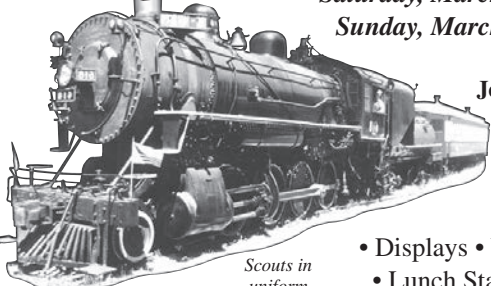

Wisconsin Department of Natural Resources approved Pinnacle's plans and specifications for a concentrated animal feeding operation west of Broadhead with conditions Dec. 28, 2016. This DNR decision marked a turning point from its rejection of the 5,800-cow dairy's previous plans a year ago January.

Thick, water-bearing layers of soil — as much as 7 to 23 feet thick — were found at many locations on the 127 acres of cropland. The bare land site is south of State Highway 59, where Decatur Sylvester Road intersects with County Highway FF.

These wet conditions made the DNR cautious about considering shallow water saturation there a perched geological condition, something Pinnacle's engineer believes he can remediate. DNR Water Resources Engineer

Gretchen Wheat also questioned feasibility of draining the wet site on a permanent basis using only gravity drainage to maintain a safe separation from four huge manure lagoons to be built at the site.

However, in a 4-page letter and 6-page engineering report made public earlier this year, Wheat recommended new plans and specifications with water monitoring and lists of conditions be approved.

DNR Waste Water Engineer Mark Cain reached by phone last week told the Independent Register the agency will not be commenting on the Green County Land Conservationist's March 2 report.

"That is between the permit applicant and the local authority," Cain said. "I'm not going to comment on that. There are many steps in the DNR's

approval process, and we still have a long way to go with this," he said.

Cain told the Register in January the DNR's next steps in its approval process for Pinnacle Dairy would be "general permits for which coverage is normally granted within about 2 weeks: a Construction Site Storm Water Runoff General Permit, and a Pit/Trench De-watering General Permit."

Cain directed the public to the DNR's topic webpage for additional information about the general permits it requires of large livestock feeding operations. He also underscored that DNR approval for Pinnacle Dairy comes with stipulations.

"Perched conditions and drainable extent must continue to be borne out," Cain said in January. "The Conditions of Approval include monitoring and reporting to DNR related to ground-

water levels, volumes of perched water removed, and demonstration that the perched saturation can be sufficiently removed to provide the required minimum separation distance (2 feet) between saturation and the elevation of the manure storage impoundment floors."

DNR staff are also reviewing Pinnacle's updated Nutrient Management Plan, which the DNR received from the applicant, the Tuls family in December 2016. The family operates two large dairy confinement operations in Nebraska, one in Rock County and a fourth near Hudson, Wis.

DNR review included study of the land area available for Pinnacle's manure application, for which Green County has cited discrepancies in more than half its parcels. Administrative codes also require the DNR to com-

plete an "Integrated Analysis," which is an environmental review, Cain said in January.

When the DNR's nutrient management review and the Integrated Analysis are complete, staff will draft a CAFO Waste Pollution Discharge Elimination System Permit for Pinnacle Dairy. DNR staff will also craft a fact sheet describing the proposed livestock facilities in plain language. "Within the next 30-60 days, the DNR anticipates the draft CAFO WPDES Permit may be issued for public comment," Cain told the Register in January.

Protect personal, financial, tax, computer information

The Internal Revenue Service has reminded taxpayers to be cautious and protect personal, financial and tax information, particularly at tax time.

The IRS urges taxpayers to be safe online and reminds them to take steps to help protect personal information and guard against identity theft. This is true all year long, but particularly at tax time, when taxpayers may anticipate hearing about a tax refund or the status of their return.

"The IRS works year-round to protect taxpayers against scams and identity theft," said John Koskinen, IRS Commissioner. "But we can't do this alone. Taxpayers can do their part by taking certain precautions to stay ahead of these would-be con artists."

Treat personal information like cash — don't hand it out to just anyone. Social Security numbers, credit card numbers, bank and utility account numbers can be used to

steal money or open new accounts. Every time a taxpayer receives a request for personal information, he or she should think about whether the request is truly necessary. Scammers will do everything they can to appear trustworthy and legitimate.

Avoid phishing scams

The easiest way for criminals to steal sensitive data is simply to ask for it.

Taxpayers should learn to recognize phishing emails, calls, or texts that pose as familiar organizations such as banks, credit card companies, or even the IRS. These ruses generally urge taxpayers to give up sensitive data such as passwords, Social Security numbers, and bank account or credit card numbers. They are called phishing scams because they attempt to lure the receiver into taking the bait. The subject line may suggest the recipient just won a free cruise or that he or she must immediately update

an account. Never open a link or an attachment from a suspicious email. It may contain malware.

Also, don't assume internet advertisements, pop-up ads, or emails are from reputable companies. Check out companies to find out if they are legitimate. When online, a little research can save money and reduce security risks. If an ad or offer looks too good to be true, take a moment to check out the company behind it. Type the company or product name into a search engine with terms like "review," "complaint," or "scam."

Never download "security" software from a pop-up ad. A pervasive ploy is a pop-up ad that indicates it has detected a virus on the computer. It urges users to download a security software package. Don't fall for it. It most likely will install some type of malware. Reputable security software companies do not advertise in this manner.

Protect personal data

Taxpayers should not carry Social Security cards with them or any documents that may include this number. Provide Social Security numbers only when necessary. Occasionally, businesses will request it when it is not essential.

Give personal information over encrypted websites only. Shopping or banking online should be done only on sites that use encryption. To determine if a website is encrypted, look for "https" at the beginning of the web address

(the "s" stands for secure). Some websites use encryption only on the sign-in page. If any part of the session isn't encrypted, the entire account and the included financial information could be vulnerable. Look for "https" on every page of the site.

Use strong passwords

The longer the password, the tougher it is to crack. Use at least 10 characters; 12 is ideal for most home users. Mix letters, numbers, and special characters. Try to be unpredictable — don't use names, birthdates, or common words. Don't use the same password for many accounts. If the password is stolen — it can be used to take over multiple accounts. Don't share passwords on the phone, in texts, or by email. Legitimate companies will not send messages asking for passwords. Receiving such a message probably means it's a scam. Keep passwords in a secure place.

Set password and encryption protections for wireless networks. If a home or business Wi-Fi is unsecured, it also allows any computer within range to access the wireless network and potentially steal information from connected devices.

Use security software

Make sure you have security software installed on all of your devices that connect to the internet. Many computers come pre-installed with firewall and anti-virus protections. A good broad-based anti-malware

program should provide protection from viruses, Trojans, spyware and adware.

Set security software to update automatically so it can be upgraded as threats emerge. Also, make sure the security software is "on" at all times. If retaining important financial documents, such as prior-year tax returns, consider investing in encryption software to prevent unauthorized access by hackers or identity thieves.

Make sure security software has parental control options to protect children from malicious websites. Educate children about the threats of opening suspicious web pages, emails, or documents.

Back up files

No system is completely secure. Copy important files, including federal and state tax returns, onto a removable disc or a back-up drive, and store it in a safe place. Save tax returns and records.

Federal and state tax returns are important financial documents that a taxpayer may need for many reasons, ranging from home mortgages to college financial aid applications. Print out a copy and keep it in a safe place. Make an electronic copy in a safe spot, as well.

These steps also can help taxpayers more easily prepare next year's tax return.

If storing sensitive tax and financial records on a personal computer, use a file encryption program to add an additional layer of security.

Interest rates remain the same for second quarter

The Internal Revenue Service announced that interest rates will remain the same for the calendar quarter beginning April 1, 2017. The rates will be:

- four percent for overpayments [three percent in the case of a corporation];
- one and one half percent for

the portion of a corporate overpayment exceeding \$10,000;

- four percent for underpayments; and
- six percent for large corporate underpayments.

Under the Internal Revenue Code, the rate of interest is determined on a quarterly basis. For

taxpayers other than corporations, the overpayment and underpayment rate is the federal short-term rate plus three percentage points.

Generally, in the case of a corporation, the underpayment rate is the federal short-term rate plus three percentage points and the overpayment rate is the federal

short-term rate plus two percentage points. The rate for large corporate underpayments is the federal short-term rate plus five percentage points.

The rate on the portion of a corporate overpayment of tax exceeding \$10,000 for a taxable period

is the federal short-term rate plus one-half (0.5) of a percentage point.

The interest rates are computed from the federal short-term rate determined during January 2017 to take effect Feb. 1, 2017, based on daily compounding.

IRS reports refunds totaling \$1 billion for unfiled 2013 tax returns

Unclaimed federal income tax refunds totaling more than \$1 billion may be waiting for an estimated 1 million taxpayers who did not file a 2013 federal income tax return.

To collect the money, taxpayers must file a 2013 tax return with the IRS no later than this year's tax deadline, Tuesday, April 18.

"We're trying to connect a million people with their share of 1 billion dollars in unclaimed refunds for the 2013 tax year," said IRS Commissioner John Koskinen. "People across the nation haven't filed tax returns to claim these refunds, and their window of opportunity is closing soon. Students and many others may not realize they're due a tax refund. Remember, there's no penalty for filing a late return if you're due a refund."

The IRS estimates the midpoint for potential refunds for 2013 to be \$763; half of the refunds are more than \$763 and half are less.

In cases where a tax return was not filed, the law provides most taxpayers with a three-year window of opportunity for claiming a refund. If they do not file a return within three years, the money becomes the property of the U.S. Treasury.

The IRS reminds taxpayers seeking a 2013 refund that their checks may be held if they have not filed tax returns for 2014 and 2015. In addition, the refund will be applied to any amounts still owed to the IRS or a state tax agency and may be used to offset unpaid child support or past due federal debts, such as student loans.

By failing to file a tax return, people stand to lose more than

just their refund of taxes withheld or paid during 2013. Many low-and-moderate income workers may have been eligible for the Earned Income Tax Credit (EITC). For 2013, the credit was worth as much as \$6,044. The EITC helps individuals and families whose incomes are below certain thresholds.

Taxpayers who are unable to get missing forms from their employer or other payer should go to IRS.gov and use the "Get Transcript Online" tool to obtain a Wage and Income transcript. Taxpayers can also file Form 4506-T to request a transcript of their 2013 income. A Wage and Income transcript shows data from information returns we receive such as Forms W-2, 1099, 1098 and Form 5498, IRA Contribution Information. Taxpayers can use the information on the transcript to file their tax return.

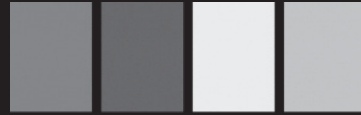

Destination Imagination teams to compete March 18

Parkview has seven Destination Imagination (DI) teams this year. The teams will compete in the South Central Regional Tournament on March 18 at Badger High School in Lake Geneva.

According to their website, "Our Challenge program is our most popular offering. At the start of the season, teams choose one of seven Challenges. After weeks spent creating, developing and practicing their solutions, they go to a local tournament. Top-scoring teams advance to state or country tournaments. The top level of the tournament is our Global Finals—the world's largest celebration of creativity."

Destination Imagination's mission statement reads, "The Destination Imagination program encourages teams of learners to have fun, take risks, focus, and frame challenges while incorporating STEM (science, technology, engineering, and mathematics), the arts, and service learning. Our participants learn patience, flexibility, persistence, ethics, respect for others and their ideas, and the collaborative problem solving process. Teams may showcase their solutions at tournaments. All of our programs are project-based, and they teach the creative process from imagination to innovation. Our goal is to help student teams learn to be creative in every aspect of their lives."

This year's challenges are: Technical Challenge: Show & Tech; Scientific Challenge: Top Secret; Improvisational Challenge: 3-Peat; Service Learning Challenge: Ready Willing and Fable; Engineering Challenge: In It Together; Fine Arts Challenge: Vanished; and Early Learning/Rising Stars.

Additionally, teams must do an Instant Challenge. Instant Challenges require teams to engage in quick, creative, and critical thinking. At a tournament, a team will receive an Instant Challenge and the materials with which to solve it. The team members must think on their feet by applying appropriate skills to produce a solution in a period of just five to eight minutes.

Are you comfortable that the Trump administration is so cozy with Putin and the Russians?

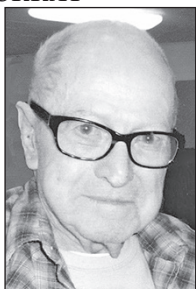
