McDermott gets green light for expansion

Business gets approval for expanded sales lot

 The Orfordville Village Board convened on Nov. 27, passing a budget and addressing business with two tenants of the business park across Highway 11.

A public hearing regarding the 2018 budget drew no members of the public, and so the board unanimously passed the 2018 general fund budget for \$1.2 million. The 2018 local tax levy was set at \$565,378.

The board issued a conditional use permit to Bright Star Child Care, naming Connie Markee as the sole owner.

Next the board discussed whether to issue a conditional use permit to Jack McDermott to expand the south-facing lot from five vehicles to up to 10 vehicles for sale.

The board engaged in some debate on the matter, Village Trustee Gary Phillips questioned whether the board was setting a precedent

McDermott said state regulations require automobile vendors to either provide or contract with a repair facility, among other regulations regarding hours, signage and others.

"The service side and the sales side often go hand-in-hand," McDermott told the board.

Board member Becky Strupp asked if McDermott would entertain expanding the lot again, given enough sales. McDermott said after the pending expansion, the lot will be mostly locked-in, with little to no room for expansion. McDermott said the business would consider purchasing another lot, and another building, if the expansion does not prove adequate.

Village counsel Timothy Lindau said the village board has ultimate discretion in awarding conditional use permits, and could impose restrictions if the body felt it necessary. Lindau acknowledged the potential for perceived selective enforcement if permits were to be issued inconsistently.

The board took a roll call vote. Trustees Beth Schmidt, Becky Strupp, Russell Rucker, and Board President Dave Olsen voted in favor. Phillips was the lone vote against.

Phillips reached out after the meeting to explain his vote. In an online correspondence, he wrote: "I have a hard time with the fact that we can give him the right to sell more cars and can deny others of selling products related to their business ... I have absolutely no problem with him selling more cars, my problem is the precedent that it

could start down the road and treating businesses fairly."

Mike Eggleston, of Eggleston

Construction, received approval for a site plan for his planned opening of a permanent location in the busi-

ness park. The next Orfordville Village Board meeting is set for 7 p.m. on Monday, Dec. 11.

Rep. Spreitzer named to tax review committee

Rep. Mark Spreitzer 45TH ASSEMBLY DISTRICT REP.

Last Thursday, Rep. Mark Spreitzer participated in his first hearing as a member of the Assembly Committee on Ways & Means. Rep. Spreitzer was appointed to the committee earlier this month

by Minority Leader Gordon Hintz (D-Oshkosh). The Committee has been expanded to include four new members in order to help conduct a top-to-bottom review of Wisconsin's tax code.

"Restoring tax fairness for the middle class is a top priority for me,"

Rep. Spreitzer said. "Wisconsinites have lost trust in state government over the past 7 years through bad business deals, misplaced priorities, and \$3 billion dollars in corporate giveaways. I want to help Wisconsinites regain trust in government by working to build an economy that works for everyone."

Wisconsin, along with the rest of

the United States, has learned that trickle-down economics do not work.

Providing tax breaks to the top 1% rather than reducing the tax burden on the middle class does not boost the economy.

"In order to make Wisconsin thrive, we should cut taxes for the middle class, for working families, and for seniors," Spreitzer said.

"We must show Wisconsinites they can trust their elected leaders to do what's best for everyone, not just for the special interests and those at the very top."

The Assembly Committee on Ways and Means will have four new subcommittees that will examine specific areas of the tax code: Sales and Use Tax, Local Government Taxes and Funding, Excise Taxes and Fees, and Personal and Corporate Income Taxes.

Rep. Spreitzer has been named to the Subcommittee on Sales and Use Tax.

Green County steer weigh-in end of month

The annual Green County Steer Weigh-In will be held on Saturday, Dec. 30, 2017 at Equity Livestock, located south of Monroe from 8 to 11 a.m. In case of inclement weather the snow date will be Saturday, Jan 6.

An announcement will be made over WBGR radio prior to 8:00 a.m. on the morning of December 30th if the weigh-in will be re-scheduled due to inclement weather.

All exhibitors who plan to show steers at the 2018 Green County Junior Fair must have their steers weighed and identified at this weigh-in. Each exhibitor can identify a maximum of 5 steers. USDA radio frequency identification tags will be used to identify each steer for the county fair. Exhibitors will be required to provide the premise ID number for the farm that the steers will be housed at.

Green County Fair exhibitors must reside in Green County or be a member of a Green County FFA or 4-H

Club, to have their steers weighed and identified at this weigh-in. Steers must also be identified and weighed to be eligible to participate in the 2018 Green County Fair Meat Animal Auction, Junior Steer Show and the Steer Performance Class at the Green County Fair.

A steer performance class will be held again in 2018. Steers entered in the performance class will be scanned for carcass merits and will not be sent for harvest during the fair. This will allow youth to exhibit the same steer in both the performance and the market steer classes with the exception of the Grand and Reserve Champion Performance Steer. The grand and reserve champion performance steers will be selected based on their rate of gain, live show placing and scanned carcass data.

Exhibitors are reminded that steers must have a rate of gain of two or more pounds per day to be eligible to enter the performance contest or to be

sold in the Green County Fair Livestock Auction. The minimum County fair auction weights are 1,300 pounds for dairy steers and 1,100 pounds for all beef market steers. Steers must meet these minimum final weights at fair time to be eligible to sell in the livestock auction and to participate in the steer performance contest.

This weigh-in is only for steers that will be exhibited at the Green County Fair. Steers that will be exhibited only at the WI State Fair will be self-identified by exhibitors and are not required to attend this weigh-in.

The Green County Beef Producers will be assisting with the weigh-in. Record books for the Green County Meat Animal Sale and fair rules will be distributed to all exhibitors at the weigh-in. Kewaunee co. official visit covers CAFO lessons, complications

On Aug. 8, 2017 the Green County Board passed a county wide moratorium on animal feedlot permitting for 270 days. The purpose of the moratorium was to allow a 9 person Livestock Facility Study Group to be formed to gather and analyze scientific information and research

related to the impacts of livestock facilities of 1000 or more animal units on ground water, surface water, air quality, and public health and safety specifically as they apply to Green County, and to make recommendations to the County.

The Livestock Facility Study Group was formed and has been meeting regularly since then. This past Tuesday, at the Study Group

meeting, Supervisor Chuck Wagner, a board member from the Kewaunee County Board, made a presentation to the Study Group about the issues they are facing in Kewaunee County relating to the high concentration of confined animal feeding operations and their hydrogeologic challenges.

The study group was able to ask questions and have a discussion with Supervisor Wagner. There was time, and the floor was opened to the attending public to ask questions as well. It was a very interesting presentation and discussion. Supervisor Wagner described the challenges that much of Kewaunee County is facing including contaminated wells and ground water, state and local regulations, zoning, property values, and how their communities are handling these challenges.

The Livestock Facility Study Group meets the second and fourth Tuesdays of the month, with variances in the month of December. These are open meetings and the public is welcome. If you are interested in what the group is doing but cannot attend the meetings, the agendas, notes and videos of the meetings, and more can be found on the UW Ex-

tension site here: <https://green.uwex.edu/livestock-facility-study/> This group is doing important work for our county and the people who live here and call it home.

The next meeting is Tuesday Dec. 12, from 12:30 to 2:30 p.m. in the Green County Justice Center Multipurpose Rooms 2 & 3. Todd Jenson, Green County Land and Water Conservation Department, will be giving a presentation on "Green County Ordinances".

On Tuesday, Dec. 12 is also the next County Board meeting, at 7 p.m. in the Historic Courthouse in Monroe. There will be a presentation on the status of the roads in Green County. The agenda will be available on the Green County website, www.co.green.wi.gov.

Comets lock down Braves in victory

The Albany Comets (1-2 overall) made quick work of Belmont 61-38 in a Six Rivers crossover matchup last Friday.

The Braves jumped to a 9-2 lead. Albany came out ice cold from the field. Belmont attacked the Comets' 2-3 zone in the opening minutes getting high percentage shots. The Braves moved the ball quickly against the zone opening up the inside. Belmont got a number of post touches in the early stages.

Albany responded in a big way going on a 30-3 run to take a commanding 32-12 lead. Junior Corbin Kelley connected on a corner three and junior Jamison Stauffacher scored on a putback during the run.

The key to the Comets run was the defensive adjustment. The Comets wing defenders Kelley and junior Josh Dahl, started to anticipate and move quicker.

"Belmont didn't really have the free range to get up an easy pass into the post. Then once we were able to keep them passing on the outside then we had them where we wanted them," head coach Derek

Allen said.

"We really locked them down defensively."

The Comets pushed the lead to 49-22 midway through the second half. Senior Logun Parker dialed up a left wing three off an excellent extra pass by Kelley. Dahl had a conventional three-point play on a slash to the rim. The lead ballooned to 60-29 with a 7-0 run. Kelley had a three-point play and baseline drive.

The Comets had three players in double figures. Dahl led the Comets' offensive charge with 16 points. Kelley contributed 15 points and Stauffacher chipped in 14 points for the well-balanced Comets' offensive attack.

"Coming off a tough loss against Brodhead last weekend, we were looking for our first win of the season," Allen said.

"Belmont has struggled a little bit so it was one we thought if we want to accomplish what we want to accomplish this year it's a team we should be able to handle. After the rocky start we definitely did that. It's good to get out of there with a win."

Vikings shoot the lights out against Dodgeland

The Vikings (2-1) put on a shooting clinic en route to a 71-57 victory over Dodgeland in a Trailways crossover matchup last Thursday.

The opening 12 minutes saw both teams exchange blows and mini runs. Junior Eli Hoscheit converted a fast break layup and connected on a three to put the Vikings up 12-7. Hoscheit created a nightmare for the Trojans defense all night as he created several big plays.

Dodgeland responded with a 9-0 run to take a 16-12 lead. Zach Yuenger finished on the block and Matt Moynihan dialed up a right wing three to cap the momentum swing. In a game of runs, the Vikings came back with a 6-0 run to go up 18-16. Junior Adrian Meza converted down low on a bank shot after a cut across the lane and Hoscheit buried a long ball during the stretch. Parkview got valuable minutes off the bench from senior Samuel Nelson after Campbell was whistled for his second foul.

Late in the half, Dodgeland got separation going a 9-0 run to go up 30-21. Yuenger did damage with a conventional three-point play and finished an uncontested shot on the block as the Vikings back side help was slow to react. The Vikings played a 2-3 zone in the first half and Yuenger punished that zone. Yuenger had a game-high 31 points.

“Yuenger had a really good drop step. He knew how to use his body to get that position and he was hard to handle. He would kind of roll left to the strength of his right hand. He is a good player,” head coach Mike Striegl said.

Over the final three minutes of the half Parkview took advantage of the charity stripe. The Vikings went 7-for-9 from the free throw line to get back into the game. Senior Ri-

ley Carroll delivered a perfect pass to Hoscheit, who cut backdoor for an uncontested layin at the rim.

The game turned early in the second half as Parkview exploded on a 12-2 run to take a double-digit lead at 49-39 with 11 minutes left in regulation. Hoscheit sparked the run with a tough floater in the lane. Junior Aydon Campbell had a couple inside conversions during the game-changing run. Junior Jarrett Brown capitalized on a Trojans turnover with a fast break layup.

“I think finally the stuff that we practiced all week was executed. We finally ran it patiently enough to get the shots we wanted,” Striegl said of the Vikings’ 12-2 run.

“We were getting steals off that 3-2 zone that’s where we picked up pushing the ball. We have some people that can finish.”

The Vikings switched to a 3-2 zone in the second half and that move worked out for the Vikings. Carroll sagged in the zone and Parkview fronted Yuenger making it hard to enter the ball. The Vikings limited Yuenger to nine points in the second half.

Dodgeland immediately answered with a 6-0 run to slice the deficit to 49-45. Seth Christopherson blew by his defender on a baseline drive and drilled a left wing three to fuel the run.

The Vikings put the game away with a 7-0 run to go up 61-50 with three minutes remaining in the contest. Parkview drilled two back breaking threes to seal the win. Junior Justin Balch knocked down a corner three and Brown connected on a left wing three-pointer. Parkview shot the ball extremely well from the perimeter knocking down eight long balls in the contest.

“Last year was my first year and we shot better from three land than

we did the paint. It’s started that way again this year. We don’t have a lot of big guys. It’s going to be part of our game this year,” Striegl said.

Down the stretch the Vikings buried eight free throws to deliver the final knockout blow.

Parkview had four players in double figures. Hoscheit paced the Vikings’ offense with 25 points with 19 coming in the first half. Balch contributed 14 points all coming in the second half. Brown added 13 points including three three-pointers. Campbell chipped in 13 points

and several rebounds in the contest. “Campbell’s very physical in there. He is very good at getting the boards and then Brayden Tracy was a huge spark for us tonight. He did a really good job in there defensively and moving the ball and doing his job,” Striegl said.

Deer season not over

The nine-day gun deer hunt may be over, but hunters can still participate in the muzzleloader season, archery and crossbow seasons and two antlerless-only gun hunts.
 The annual statewide four-day, antlerless-only hunt will take place Dec. 7-10. Hunters may fill any unused antlerless tags while hunting in the proper deer management zone, unit and land type specified on the tag.

In addition, the antlerless-only holiday hunt will be offered in 17 farmland units from Dec. 24 - Jan. 1, 2018. These seasons are used at the request of County Deer Advisory Councils and utilized in units with high deer numbers in need of antlerless harvest to slow overall herd growth. Hunters may fill any unused antlerless tags in their proper deer management zone, county and land type. Any unit where the holiday hunt is not offered will be open for archery and crossbow hunting, and bucks may be taken.
 Any legal firearm, crossbow or archery equipment may be used during the statewide antlerless-only and holiday hunts.

Additional opportunities are also available for U.S. Armed Forces members and Class A and C disability permit holders. More information is available in the 2017 regulations [PDF].

The archery and crossbow seasons will remain open through Jan. 7, 2018 statewide.

Metro sub-units have special deer seasons that include the gun deer season to remain open through Dec. 6, while archery and crossbow seasons remain open through Jan. 31, 2018. All hunters except waterfowl hunters are required to wear blaze orange or blaze pink clothing during any open firearm deer hunt. Other outdoor enthusiasts recreating on public lands are encouraged to wear bright colors for their own safety during these periods.

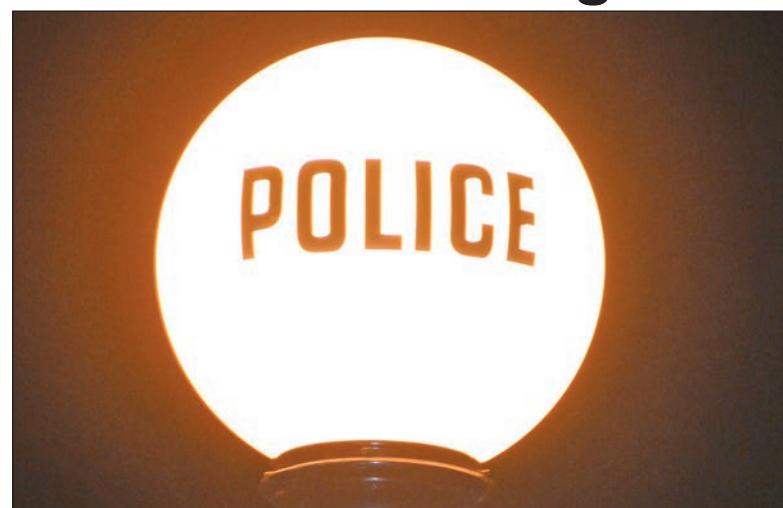
