Governor Walker announces no-interest loans now available for flooded small businesses

SCOTT WALKER PRESS RELEASE

Governor Scott Walker announced the Wisconsin Economic Development Corporation (WEDC) has awarded a \$755,000 grant to the Madison Region Economic Partnership (MadREP) to provide no-interest loans to small businesses in south-central Wisconsin that were impacted by the recent flooding.

Businesses in eight counties will be eligible for microloans of up to \$15,000, which will provide them with a short-term source of funds for repair work and operating expenses until more long-term recovery funding can be secured. The loans have a two-year repayment period, with payments deferred for at least six months.

"Just weeks after the WEDC Board approved its new Disaster Recovery Microloan Program, we are ready to start providing loans to businesses that have been hard hit by the flooding and need some help for restoration work and related expenses," said Governor Walker. "We realize there are many small businesses still struggling to recover from the flooding and these loans will give them the funds to help them quickly recover and get back on track.

Under the \$2 million program, WEDC awards grants to its regional partners, which in turn issues loans to businesses. In addition to MadREP, WEDC expects to provide grants to the Southwestern Wisconsin Regional Planning Commission and the Mississippi River Regional Planning Commission, two regional organizations in areas hit hardest by the flooding and severe weather in late August and early September.

MadREP is now accepting loan applications from businesses impacted by the severe weather. To be eligible

in the MadREP region – Dane, Rock, Sauk, Dodge, Iowa, Columbia, Jefferson and Green counties. Businesses also must have suffered measurable physical damage because of the disaster and must intend to resume business operations in the community as quickly as possible.

The loans can be used for procurement of cleanup and restoration services, operating expenses, temporary space, and repair and reconstruction

"Businesses in our community are still struggling to recover from August's flood and wind damage," said MadREP Acting President Michael Gay. "The program is designed to provide business owners with a readily available financial resource to make repairs and replace equipment."

In Dane County alone, 126 busi-

jor damage, according to Wisconsin Emergency Management. In Sauk County, 32 businesses sustained \$900,000 in damage.

Van Nutt, executive director of the Middleton Chamber of Commerce, said the funds provide much-needed assistance for local businesses, which sustained about \$30 million in structural damage.

"We are appreciative of MadREP nesses sustained \$21 million in administering WEDC's Disaster Re-

"With more than 40 businesses affected by the August 20 historic rains in Middleton, this program comes at an important time for small businesses that are experiencing a very tight cash flow during their recovery.

Drinking water testing available GREEN COUNTY UW-EXTENSION RELEASE

An exciting opportunity to learn about the water you drink is being offered to all residents with private wells in the Towns of Decatur, Jefferson, Spring Grove, and Svlvester. However, others in the county may also take advantage of the opportunity to test their drinking water.

If you are interested in learning more about drinking water and the quality of your water, this program is an opportunity to have your well water tested at a reduced cost and learn of the results during an educational program with drinking water experts.

Groundwater specialists strongly encourage rural residents to test their water at least once every two years.

This program is neither mandatory nor regulatory. It is completely voluntary. Those who participate receive the results of their water tests during an educational program the evening of Thursday, Dec. 13. Results are kept confidential.

Special bottles are required for these tests. There is a cost for this testing. You may choose one or more of the testing

packages described below.

Options for Well Testing

• Homeowner Package (Includes tests for nitrate, coliform bacteria, pH, alkalinity, and hardness.) Cost: \$52

• Metals Package (Tests for arsenic, lead, copper, iron, zinc, calcium, magnesium, manganese, sodium, potassium, and sulfate.) Cost: \$49

• Triazine Screen (Includes tests for triazine type pesticides like atrazine) Cost: \$30

If you choose all three packages the cost is \$123, a discount of \$8.

were damaged in late August and early September following several weeks of intense storms, tornados and heavy rainfall across much of southern and central Wisconsin. These storms produced devastating flash flooding in multiple regions, resulted in seven dam failures, and caused several lakes and rivers to spill out of their banks and damage homes, bridges and roads.

More than 300 businesses statewide sustained nearly \$34 million in damage, while more than 1,200 homes sustained more than \$25 million in damages, according to Wisconsin Emergency Management. Governor Walker has asked President Donald Trump to declare the 18 counties as federal disaster areas.

Green County is getting close to adopting a county ordinance on Wind Energy System Siting

A proposed ordinance was distributed to the Green County Board at the October County Board meeting, with the intention to discuss and vote on it at the upcoming November Board meeting.

The Land Use and Zoning Department and Committee have put the proposed ordinance together, following state guidelines closely. With the expectation of a 24-turbine wind farm locating in Jefferson Township, a siting ordinance is prudent.

This ordinance addresses both large and small wind energy systems; it will create Title 4, Chapter 11 of the Green County Code. The members of the

County Board were encouraged to contact the Zoning Department and Corporation Counsel with questions while reviewing the ordinance prior to discussion and voting next month.

I would encourage residents to express any concerns or questions about this proposed ordinance to their supervisor as well.

The October County Board meeting was held at Pleasant View Nursing Home with tours available before and after the meeting. The tours focused on the newly renovated areas of the nursing home, which are beautiful, efficient, and are already proving to be an asset to our county and community.

There is a referendum on the November ballot requesting an increase in

the levy limit for the purpose of paying a portion of the cost of operating and making capital improvements at Pleasant View Nursing Home. The amount requested is continuing at the current rate of up to \$790,000 per year for six years (2019-2024), which is the same rate since 2015 and would not increase current property taxes.

The current referendum is expiring, and this referendum is requesting an extension. Pleasant View is an asset to our community, filling a need that would otherwise go unmet. Terry Snow, the administrator of Pleasant View, is willing to talk with any individual or small group about Pleasant View and the referendum. Please contact her or your supervisor with any questions. 



This year the Trick or Treat hours in Brodhead are 4 p.m. to 7 p.m. on Fri., Oct. 31. The City of Brodhead wants to make sure everyone stays safe while participating in Halloween events. Here are some safety tips for kids, parents, and homeowners.

If you go Trick or Treating the two most important safety tips are to be aware of traffic and be seen in the dark. It's important to walk, not run, from house to house; especially when crossing the street. Sudden and unexpected movements into traffic are a major cause of

pedestrian accidents. Inexpensive LED flashlights and glow sticks provide several hours of light and help drivers see you.

Parents or an older sibling should accompany young children. Please respect every home owner's property and use the sidewalk when going house to house, where there is no sidewalks walk on the left side of the street facing traffic.

On Halloween night our streets experience increased traffic flow with parents dropping off car loads of trick or treaters. Drivers should take extra caution by slowing down and staying alert for pedestrians. Parents; tell children to bring candy home before eating it, although tampering is very rare all candy should be inspected and anything suspicious should be discarded. Children should wear proper fitting costumes and masks should not obstruct their sight. Lastly, out of courtesy only go to houses that have an outside light on.

General Halloween Safety Tips:

- **Trick or Treaters** Obey traffic signals
- Stay in familiar neighborhoods
- Don't cut across yards or driveways.
- Wear a watch you can read in the dark.
- Make sure costumes don't drag on the ground.
- Shoes should fit; even if they don't go with your costume.
- Wear clothing with reflective markings or tape. Stay away from and don't pet animals.

Parents

- If your children go on their own, have them wear a watch that can be read in the dark.
 - Look for costumes made of flameretardant material.
- Older children should know where to reach you and when to be home.
 - You should know where they're going.
- Look at candy wrapping carefully and toss out anything that looks suspect.

Homeowners

- Clear your yard of trip hazards such things as ladders, hoses, dog leashes and flower pots.
- Pets frighten on Halloween; protect them from cars or inadvertently biting a trick-or-treater.
- Battery powered LED Jack o'lantern candles are preferable to a real flames.
- If candles are used place the pumpkin far from where trick-or-treaters walk or stand.
 - Keep paper or cloth yard decorations from blowing into a flaming candle.


