Rock County tree sale continues

The Rock County Land Conservation Department is still taking orders for its yearly tree and shrub sale. Inventory of trees and shrubs is limited, so order early for best selection.

Trees and shrubs come in single-species bundles of 10 for \$15.00, 25 for \$25.00, or 50 for \$45.00, plus tax. All seedlings are bare root.

Trees come in the following sizes: 18-24" black walnut, bur oak,

hackberry, red oak, sugar maple, and white oak; 12-18" Kentucky coffee-tree; 7-15" Colorado blue spruce, Norway spruce, white pine, and white spruce.

Shrubs are 18-24" in American plum, Michigan holly, and nanny-berry; and 12-18" in arrowwood viburnum.

Tree protectors (four feet tall) are available again this year, as is Root

Dip Planting Gel.

All plants will be ready for pick-up around mid-April. Parkview Athletic Hall of Fame: a place for athletics, love, and pride

Parkview High school was a Viking sports time capsule last Friday night. During halftime of the girls' varsity basketball game, four individual athletes were honored, along with the 1949-50 football team.

The bleaches were packed to the brim, and the gymnasium erupted in cheers and applause after each inductee's name was announced over the loudspeaker.

The Athletic Hall of Fame was first erected in 2016 when the new gymnasium was built. This year's inductees were the second class to be recognized.

David Nelson ('64) was a decorated three sport athlete (baseball, basketball, football). He is a letter winner in all three sports. Some of his baseball accomplishments include: 31-7 career pitching record, 22-0 conference record, three no-hitters, three-time MVP. Nelson went on to play semi-pro baseball with the Beloit Blues.

Jan Potter ('80) was also a three-sport athlete as part of the track and field, football, and basketball clubs. Potter was a letter winner in all three sports and a member of two Regional title teams, one Sectional title and three Conference teams in his time with the track and field club. He also won the Individual WIAA State Meet title for the 400-meter dash in 1980. Potter went on to play football at Milton College.

Also inducted was Chick Kohlhepp, a three-sport coach, whose ca-

Green County Board Updates

 COUNTY BOARD SUPERVISOR
 Beside the CAFO issue, all seems pretty quiet on the county board front. The January county board meeting was cancelled due to lack of business. None of the committees on which I serve met this month, and in talking with our county conservationist, I found out that the Land and Water Conservation committee will not be

meeting in February. Things seem to be slowing down during these winter days right now. The Government Services Building Committee is meeting on Feb. 2 at 9 a.m. if you are interested in how that project is progressing. They will be meeting at the Green County Courthouse in the first-floor conference room. I received a number of emails

and phone calls after my last article in which I talked about the proposed mega dairy. Thank you, everyone who called and emailed. I have made several phone calls to our county conservationist, the DNR, and other agencies asking questions. The main concerns of the Green County residents with whom I spoke are economic issues, water concerns, and manure spreading.

I spent some time looking at the easements that were filed at the county Register of Deeds. These are the parcels that have been contracted to take manure from the CAFO if it proceeds. There are many parcels across Green County and several in both Rock and Lafayette counties. Areas that seem to have a high concentration of parcels taking manure are Albany, Decatur, and Mt. Pleasant, although there are

quite a few all over the county. The contracts are public record, and you are welcome to view them. You can contact the Green County Register of Deeds. Also, I have been keeping up with other counties that are struggling with the appropriate siting of CAFOs and CAFO issues: Bayfield, St. Croix, and Kewaunee. Operations this size can have such an enormous impact; it is important to know what other counties are experiencing. Our county conservationist, his team and the Land and Water Conservation Committee are working diligently on this issue. Should you have questions or comments about county issues, please contact your county board supervisor. As a supervisor, I welcome hearing from residents of Green County. 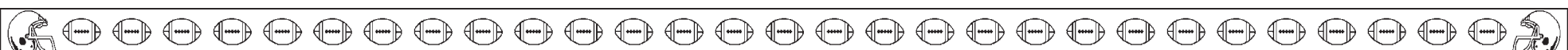

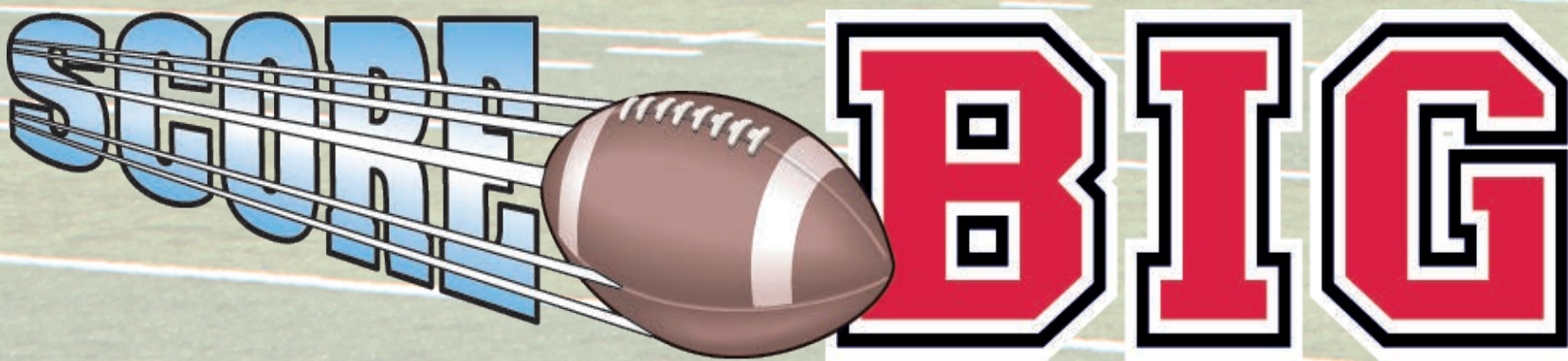

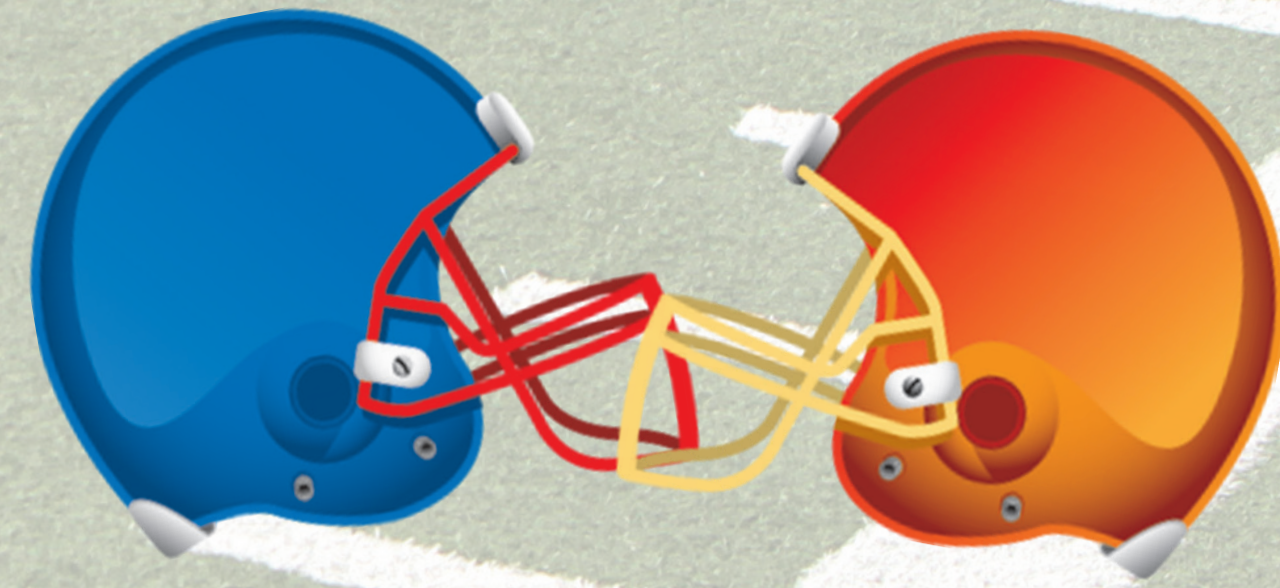

Local school bus drivers complete specialized driver training

Every driver has driven his or her vehicle in some type of skid at one point during the driving experience. Whether it was to stop the vehicle quickly, swerving to avoid a hazard, or losing of control on slippery a surface, the situation was serious.

Many drivers overrate their abilities and often underestimate the capabilities of the vehicle they are driving. This combination often results in serious crashes simply because the driver is making decisions based on incomplete data.

Recently, a team of professional school bus drivers from the Brodhead team of Kobussen Buses, Ltd., traveled to Appleton for specialized training, which simulated a variety of emergency situations. Those making the trek included: Keegan Lee (Brodhead), Peggy Rieff (Brodhead), Cathy Kwasneski (Brodhead), Jim Schilz (Monroe), Josh Martin (Janesville), Al Barry (Avon), Shawn Harriel (Janesville), and Rodney Davis (Janesville).

This hands-on experience affords the driver an opportunity to make better decisions when confronted with an actual emergency associated with everyday driving activities, thus minimizing the devastating results associated with accidents or avoiding the occurrence completely.

The course—Decision Driving conducted by Fox Valley Technical College—included both time behind the wheel and an in-classroom session. “The behind-the-wheel part of the program starts on the skid pad, which simulates

a slick driving surface that gives you experience in pre-accident conditions,” Joe Kobussen said. “In one exercise, you start by going around in a circle, increasing your speed until the bus starts sliding. In another, you drive straight ahead to test your reaction time. There’s also one in which they hit the brakes and you have to pull out of the skid and re-gain control.”

“On the skid pad, you quickly learn that there are many aspects of driving that you’re unaware of,” Brad Plamann, a Fox Valley Technical College driving instructor, said. “And, it definitely shows the limitations of your vehicle. I’ve heard many students report that what they learned through skid pad training could have prevented catastrophes on the road.”

For Kobussen Buses, the program has been very effective at reducing not just the number of accidents, but also the severity of accidents. “My brother and I have both been through the course and believe every driver should take it,” Kobussen said. “It’s not required by law, but we insist on it because we firmly believe that it makes our employees better drivers.”

Kobussen terminal manager Drew Burns heartily agrees. “Every student who takes driver education should take this course,” he said. “It changes the way you drive. You’re suddenly very aware of road conditions and pay more attention to all the cars around you. Everything I learned in the course I apply every time I get behind the wheel—even in my own car.”

Green County Sheriff's Report

All charges reported here are merely accusations. A defendant is presumed innocent until proven guilty in a court of law. Sheriff's deputies reported the following incidents occurred.

The Green County Coyote Hunters Club has a mission to control predator populations by hunting coyotes and fox with the aid of dogs; to promote safety, fellowship, and good sportsmanship; and to cooperate with other organizations that share these objectives.

UW-Extension Master Gardener training coming soon

If you are interested in learning how to better manage your lawn, trees, shrubs, or garden and share your gained knowledge with others, you may want to register for the UW-Extension Master Gardener Level One training that will be offered in Monroe later

this winter. Classes to learn more about horticulture and to become a UW-Extension Certified Master Gardener Volunteer are being offered on Tuesday evenings (6 to 9 p.m.) from Feb. 21 to Apr. 25 at the Green County UW-Extension Office, 2841 6th Street, Monroe. Two Saturday sessions, March 11 and May 6, will also be part of the training to be offered in 2017.

University of Wisconsin-Extension specialists and Green County Master Gardener volunteers will help class participants learn more about Soils, Plant Nutrition and Composting, Botany, Plant Growth and Propagation, Lawn Care, Trees and Shrubs, Entomology, Plant Diseases, Weed ID and Invasive Plants, Integrated Pest Management, Vegetables, Fruits, General Gardening, Backyard Wildlife, Landscaping with Herbaceous Plants and Perennials, and Houseplants.

Participants receive two, three-ring binders featuring the latest

university reference information on topics covered during the course.

In exchange for this instruction, participants are required to volunteer a minimum of 24 hours of volunteer service as a resource for horticulture inquiries in their community. This can be done through the UW-Extension Office in Green County or through many of the community projects done by the Green County Master Gardeners Association.

The cost to attend the 12-week program is \$150 per person. This fee includes a binder with University of Wisconsin Horticulture Publications, a Master Gardener Handbook, and admission to the Green County Master Gardeners Gardening Symposium on March 11. A limited number of scholarships are available to help pay a portion of the cost for those who qualify.

The program is open to anyone 18 years of age or older. Registrations must be received by Feb. 9 at the Green County UW-Extension Office. A minimum number of participants is required to run the classes.

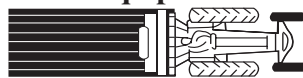



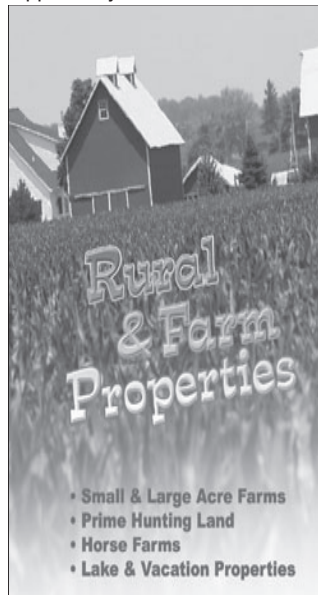

Pastor's Corner

A week ago, I went to an inaugural public meeting in a Beloit congregation. The gathering was organized for the purpose of discussing and promoting to the Beloit City Council the possibility of the creation of a (yet to be determined) form of an identification card (a photo ID) that would be used strictly and only for the citizens of the City of Beloit. I was invited to attend by another clergy person. We met in the church basement dining room.

When we arrived early, there were very few people present. At one table sat a group of young people who we later learned were Beloit College students.

Another table had about a half dozen women of various ages and backgrounds. One of the women came to where we had been seated and introduced herself to us. She identified herself as a leader from the

Beloit city council. There to show her support for the proposal to get citizens of Beloit to sign a petition, she would be suggesting to the Beloit city council that they allow this action group to continue studying and planning for how a Beloit city ID might be established, how it might be of benefit, how it would be implemented and maintained, and what it could and could not be used to do. There would be a fee to the user to cover the cost associated with the ID.

Sorry, I am getting ahead of myself. First, there is a citizen's petition being passed around in Beloit to be signed by ONLY Beloit city citizens. When there are five hundred signatures collected, the petition will go before the Beloit City Council. The petition requests the council allow there to be further investigation and consideration for the possible use of a Beloit City photo ID. The council woman present said initial conversations with the Beloit Police Depart-

ment were favorable toward the concept.

Across the tables of the hall as it filled were multiple generations of family. A few families attending included grandparents, parents, and children of elementary school age. As the crowd continued to gather, they nearly filled all of the seats at each table.

As the meeting was about to begin, I noticed that the variety of ages now stretched from the age of infants to a few folks who were likely in their seventies.

The wide range of dress that people wore suggested people came from different economic statuses, from different employment statuses, from different educational backgrounds, and from different cultural backgrounds. A small number of those in the meeting were Hispanic. The remainder appeared to be Midwesterners, Black and White.

Two bi-lingual women led the pre-

sentation. They represented the local Beloit council that is interconnected with an association of over 1,000 local Latino action councils. The group represents itself in a growing number of cities throughout the United States. The national organization is called LULAC (League of United Latin American Citizens), and LULAC's webpage (lulac.org) claims it is the largest and oldest Hispanic organization in the United States. The primary actions and the control of the Beloit LULAC council is at the local level.

For me, there were fascinating things I learned about myself from that event. I was reminded of all the sweat and anxiety I had back in those high school classes. I still occasionally stumble into a reward for struggling through that class. The payoff this time came when the women leaders in the LULAC meeting first spoke in one language and then repeated what they just said in the second language.

From the far recesses of my nearly fifty-year-old brain came the connections of words and phrases of Spanish that flashed to life again. There might have been smoke drifting out of my ears from those grinding gears and ancient cobwebs in my head.

I also reconnected with the really deep bond I have with my baby sister. She came into our family as an infant, during the same time I was trying to learn high school Spanish. Her biological parents were Puerto Rican and White. Now she has mostly adult

kids. They are even more multi-ethnic - Puerto Rican, Black and White. I love them dearly. Their lives are significantly different than mine.

The meeting also reminded me of uncomfortable things in my life and my nuclear family's lives. Early in the LULAC meeting, this question was asked of everyone: "When was the last time you had to use your photo ID?" As people in the crowd described over and over their recent experiences, I was scrambling to think of my last time. Nothing instantly came to mind. Eventually, I remembered I needed my photo ID at the airport for the last time we flew. Over a week later, I recalled using my ID to vote and then when I test drove a new (to us) vehicle.

My skin color, the way I dress, my receding and thinning hair offer me privileges in our society. I am grateful for that. But I have watched and been furious when my sister's -- and her children's -- skin color and their hair and the way they dress have prevented them from receiving the privileges I receive -- privileges that I take for granted. Such seemingly small privileges, like not having to worry about constantly needing to use my photo ID, should be made available more equally. It's a tiny start toward more equality and more justice in our society.

He has told you, O mortal, what is good; and what does the Lord require of you but to do justice, and to love kindness, and to walk humbly with your God? (Micah 6:8).

Tractor, machinery safety courses beginning in March

The 2017 Green County Tractor and Machinery Safety Certification Course will begin in March.

Wisconsin Law states that "No person may direct or permit a child under age 16 years to operate a farm tractor/self-propelled implement of husbandry on the highway unless the child has been certified as successfully completing a tractor and machinery operation safety course."

The Federal Child Labor Regulations state that "it is unlawful to hire or even permit without pay any youth under age 16 to participate in any work activities listed as hazardous, unless:

- 1.) The youth is working on a farm owned and operated by a youth's parent; or
- 2.) The youth has a training certificate which provides an exemption from certain hazardous work activities."

The 2017 course schedule is as follows:

- *Monday, March 13, 6:30 to 9 p.m., split between Hennessey Implement and the Green County Justice Center;
- *Tuesday, March 14, 6:30 to 9 p.m. at Albany High School;
- *Saturday, March 18, 9 a.m. to 1 p.m. at Argyle High School;
- *Tuesday, March 28, 6:30 to 9 p.m. at New Glarus High School;
- *Monday, Apr. 3, 6:30 to 9 p.m. at MERIT

Center in Monroe;

*Saturday, Apr. 8, 8 a.m. to 3 p.m. at the Juda Community Center;

*Tuesday, Apr. 18, 4 p.m. to 7 at the Green County Fairgrounds;

*Wednesday, Apr. 19, 4 p.m. to 7 at the Green County Fairgrounds; and

*Thursday, Apr. 20, 4 p.m. to 7 at the Green County Fairgrounds.

Please note that this is a 24-hour state and federal course, and participation in all 24 hours is required. A parent or guardian is required to attend the first session with the child. Some sessions will be held outdoors, so please dress accordingly.

Class size is limited to 20 participants. First priority will be given to residents in Green County ages 14 and up. Registrations will be taken on a first paid-first served basis.

The cost is \$35 for Green County youth and \$45 for out-of-county youth. Please make checks payable to Green County UWEX. Fees cover the cost of student manuals, equipment use, and insurance.

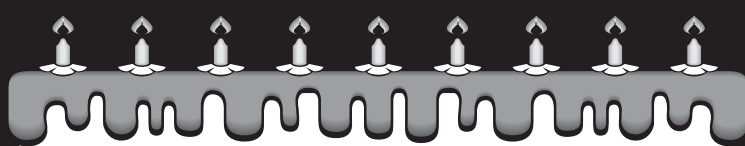
