Storms prompt DNR to urge boaters to think about water safety

DNR PRESS RELEASE

Wisconsin Department of Natural Resources officials want to remind all water-users to think safety by checking local conditions before embarking on the water.

DNR staff also urge boaters to always wear a life jacket when on the water.

Recent August storms packing record downpours have pushed lake and river levels well into flood stages.

Increased lake and river water brings tossed debris into waterways and accelerated currents in many areas of southern Wisconsin.

Head of DNR Bureau of Law Enforcement's Recreation Safety and Outdoor Skills Section, Captain April Dombrowski addressed water safety in a press release last week.

Heavy rain and rapid onset of flash floods in western Dane County and beyond in southern Wisconsin have resulted in road washouts, closures and sinkholes, Dombrowski stated.

In addition to the roadway issues, such downpours can have a major impact on water-based recreational activities.

"What may look like a simple branch floating downstream may be the top of a large tree or branch below. Sunken docks and other items may be hidden from view," Dombrowski stated.

In addition to debris, water-users should watch out for flood-level water that increase the power of the current and water flow.

"Be observant, maintain safe speeds and wear a life jacket," Dombrowski said.

The severe weather is a reminder for all residents to check local water conditions before boating, paddling, swimming or any water activity.

"Regardless of conditions, the best place for a life jacket is to wear it," Dombrowski said, "Today's models are comfortable versions. Wearing one just might save your life."

Some of these storms and heavy rains have pushed trees and other debris in the water, which create another danger.

High water levels also increase the shoreline and erosion impacts of your boat's wake, Dombrowski stated. Some areas in Dane County have implemented lake-wide slow-no-wake requirements.

Remember to always be aware of your boat's wake and impact on others and check the signage prior to launching.

Additional safety tips:

-Make a float plan, follow that plan and let someone know where you are

going.

-Always wear a life jacket. All people in either canoe or kayak are required by law to have a wearable U.S. Coast Guard-approved life jacket on board.

-Match your skill level to water and weather conditions.

-Take a boating safety class and hone your skills.

Everyone born on or after Jan. 1, 1989 must have completed a boating safety course to operate a motorboat (unless the individual is between 10 and 15 years old and accompanied by a parent or guardian). You can take an online boat safety course.

-Do not overload your vessel.

Place belongings and dry clothing in a wet sack or other waterproof container.

-Remain sober while operating your boat or paddling. Hold off on consuming alcohol until after your recreational boating outing.

Wisconsin has many popular lakes and rivers that attract many users for all sorts of water activities. And with all the users comes boat congestion and unintended user conflicts. For all water recreational enthusiasts to have a safe and enjoyable outing, it's important to slow down, use common sense and respect everyone who is on the water.

Key points for homeowners to follow for flood clean up

Recent heavy rains in many southern Wisconsin counties have affected private property owners and state properties.

The Wisconsin Department of Natural Resources is offering the guidance below as many property owners will begin assessing damage, checking wells and septic systems and removing storm related debris. In particular, heavy rains can create conditions that affect private wells and drinking water.

Private wells and drinking water

Floodwaters and runoff may affect private wells. Well owners who observe flooding or changes in their water should assume the well is contaminated and should stop drinking the water.

Homeowners are encouraged to make sure their wells are properly disinfected, then sample the well after pumping and disinfection to assure the water is safe.

Wells located in pits, basements and low-lying areas are especially susceptible to contamination.

Even without obvious signs of flooding, a well can become contaminated. More recommendations for private well owners whose wells have been inundated are available on the DNR website. Private well owners are encouraged to check wells after recent flooding in southern Wisconsin.

More information on bacteriological contamination of drinking water wells, along with lists of licensed well drillers, pump installer and labs certified to analyze water samples are available by searching the DNR website, dnr.wi.gov, for the keyword "wells."

Handling debris

DNR has compiled information on how to dispose of specific materials and items. Visit Cleaning up storm debris for more information. You can also contact local authorities to find out if there are special arrangements or resources for cleaning up and disposing of storm and flood debris.

Septic systems

The Wisconsin Department of Safety and Professional Services regulate septic systems. Look for more

information at DSPS.wi.gov, search "private onsite wastewater treatment systems program."

Floodwaters

People and pets are advised to limit contact and avoid swimming or wading in floodwaters and runoff. Floodwaters may contain bacteria and other contaminants.

Albany Carp fishing contest is Labor Day weekend

Once again, the Lake Winnetka/Sugar River Improvement Association Incorporation will hold its annual Carp Fishing Contest.

There are two categories of prizes for the most Carp caught, regardless of size.

The first category is for bow fishermen only. The second category is for all other types of fishing including Hook and Line, Spear, and Hand fishing. Seine netting is not allowed.

Prizes awarded in both categories is \$50 for first place, \$25 for second place, \$15 for third place, \$10 for fourth place and \$5 for fifth place. There is one bonus \$50 prize for the largest Carp caught in any manor determined by weight. There are also two fishing gear prizes for contestants ten years old and under.

No registration is required to compete in the contest, but you must have a valid Wisconsin-fishing license.

Qualifying Carp must be caught from the Sugar River in Albany or on the millpond (Lake Winnetka) upstream of the Albany dam. The shallow, muddy areas of the lake are where many Carp hide out.

The goal of the contest is to provide a fun way to help game fish proliferate more abundantly by removing as many Carp as possible.

You may start fishing anytime on Friday Aug. 31. Contestants can fish all weekend. The contest ends at 1p.m. on Sept. 3. Prizes will be awarded rain or shine in the park by the Albany boat ramp.

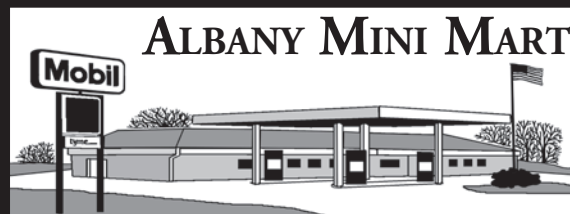

Juda School Board makes final decision for Fall referendum

After much consultation, the Juda School Board made a final decision for a referendum to appear on the Nov. 6 ballot.

Juda School Board voted in favor to place a question on the ballot for community approval. The question asks for a resolution to exceed the district's revenue cap for the 2018 to 2019 school year by \$350,000.

Due to decreasing enrollment numbers and government laws, the school is not able sustain the amount of money it needs.

Green County Board discusses referendum

Green County Board covered an array of information in their latest board meeting Resolutions and ordinances were discussed and voted on as well; all motions passed unanimously that evening.

Presentations by Monroe Clinic Hospice, Green County Library Board ; the Annual Report of the Veterans Services Office was given.

The County Board passed the "Just Fix It" resolution for the State Transportation Funding Plan. Most of the state already passed the resolution. Green County has now joined the ranks of pushing for the Governor and State Legislature to reach and implement a sustainable solution to Wisconsin's road and transportation issues.

Board of Adjustment Bylaws were approved; the bylaws were written about 20 years ago and needed updating. The Board of Adjustment is a board under the umbrella of the Zoning Department and is made up of appoint-

ed citizens.

A question to authorize a referendum to exceed the state imposed tax levy limits in 2019 through 2024 for the benefit of Pleasant View Nursing Home will be on the Nov. 6, general election ballot.

As a county-owned nursing home, Pleasant View receives funds from the county to help cover operating expenses. Several years ago, a similar referendum was passed and is expiring in 2019, thus the need to pass another referendum.

The dollar amount being asked for is the same as it has been, \$790,000 per year; there is no increase. This referendum will be presented on the ballot as a "yes" or "no" question: yes if you support the continuation of exceeding the tax levy limits for the benefit of Pleasant View Nursing Home, no if you do not.

You can find this, as well as the other resolutions, on the Green County website if you would like to read it. It is Resolution 8-3-18.

Additional news included:

-The County Board is in support of an additional full-time Assistant District Attorney position for the Green County District Attorney's Office.

The county's population has increased, and with it the workload for the District Attorney's Office, but the number of Assistant District Attorneys has not followed suit and the office has been understaffed since at least 2012.

The Green County Board thus passed the recommendation that the State of Wisconsin appoint an additional full time Assistant District Attorney to the Green County District Attorney's Office for the 2019-2021 biennium.

-Effective Sept. 1, all Green County Board Supervisors have county-issued email addresses for conducting county business. These email addresses will be updated on the county website.

Please use the new email addresses should you need to email a supervisor. This practice protects the county and the supervisors should any emails or correspondence need to be summoned; by law, all emails need to be archived for 7 years.

Also, it is good practice for supervisors to keep county correspondence separate from personal and business correspondence.

-The next County Board meeting is scheduled for Tuesday Sept. 11. Please check the location on the county website as there is a possibility that it will be held at the new Government Services Building.

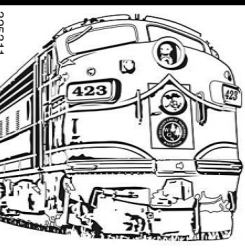

Department of Natural Resources to discuss Black Earth Creek

Wisconsin Department of Natural Resources Fitchburg Service Center is hosting a public meeting concerning Black Earth Creek.

The DNR is discussing and requesting input on possible regulation changes for the river from South Valley Road downstream to Highway 14.

Black Earth Creek is a popular Class 1 trout stream. Anglers and others can provide input on possible regulation changes. "We've documented declines in trout larger than 8 inches, and the current regulation has not improved the size structure of the fishery," said Dan Oele, DNR fisheries biologist for Dane County, in a press release. "We're interested in exploring options that will help anglers see more and larger fish."

Currently, the regulation allows for the harvest of three fish less than 12 inches. Oele said DNR is exploring options to increase size structure and abundance for anglers.

Black Earth Creek currently has high populations of young brown trout - more than 500 fish per mile in the upstream reaches. Historically, this lower stretch has also had a high number of adult fish over 8 inches and over 12 inches.

Over the last five years, however, annual monitoring has shown the lower portion of the creek has not returned to historical levels.

The meeting is Tuesday, Sept. 11 at 7 p.m. The Department of Natural Resources Fitchburg Service Center is located at 3911 Fish Hatchery Road, Fitchburg 53711.

Local officials graduate from Municipal Clerks/Treasurers Institute

Teresa Withee, City of Brodhead Clerk/Treasurer, was among 108 officials who graduated from the 2018 Wisconsin Municipal Clerks and Treasurers Institute.

UW Green Bay, which helps host the training with professional associations, announced Withee's graduation in a press release last week.

This training program was held July 15 through July 20. It is one of the largest programs in the United States and is recognized nationally and internationally. It is designed to advance the professional development of local government officials in Wisconsin.

This year, 325 clerks and treasurers from all over the state of Wisconsin attended the institute, held at the Radisson Hotel and Conference Center in Green Bay.

The Municipal Clerks & Treasurers Institute is the only training program in Wisconsin that trains municipal clerks and treasurers how to do their jobs.


Each summer, municipal clerks, treasurers and other officials participate in a week of continuing education training courses.

The curriculum is progressive in nature and focuses on development of technical skills, administrative knowledge, leadership abilities, and financial management.

Local government officials completing the 3-year sequence of pro-

grams earn all of the education points needed for national certification. Additional points are earned by experience in local government and participation in other meetings and educational seminars.

Officials holding the title of both clerk and treasurer are eligible to receive both the clerk and treasurer certifications by completing a fourth year at the Institute.

Application period opens for hunting antlerless-only deer at Sandhill Wildlife Area

Hunters can take part in a one-day antlerless deer hunt this fall at Sandhill Wildlife Area.

The 9,150-acre experimental hunting area is in central Wisconsin.

State Department of Natural Resources staff are conducting this hunt to reduce the deer herd within the wildlife area on Saturday, Nov. 10.

"Following three consecutive mild winters, this special hunt opportunity is necessary to adjust population levels and sex ratios to achieve the deer management goals desired on Sandhill," said Darren Ladwig, DNR wildlife biologist, in a press release.

To enroll in the hunt, successful applicants must complete a 2018 Sandhill Antlerless Deer Permit Application. That permit application is available at all DNR Service Centers, Sandhill Wildlife Area, and on the department's website.

All selected participants will be required to attend a one-hour clinic Saturday, Sept. 29 at the Sandhill Outdoor Skills Center, located within Sandhill Wildlife Area. Individuals selected will receive a confirmation letter or email along with clinic information and payment instructions. Payment is due Friday, Sept. 21. Once clinic times

are assigned, no further changes will be made.

Clinic fees are \$20 for adults and \$15 for youth hunters ages 15 and under. As a reminder, do not send fee payment with the initial application. Participants are being issued bonus permits following completion of the clinic. Please read the application for complete rules and restrictions.

Participation is being limited to the first 100 completed applications received. Applications must be mailed or delivered in person, and must be received by Sunday, Sept. 9. No telephone, fax, or email registrations will

be accepted.

Applications will be accepted on a first-come, first-served basis at Sandhill Wildlife Area, located at 1715 County Highway X, Babcock.

The Sandhill office is open Monday through Friday from 8 a.m. to 2 p.m. All applicants must possess a valid Wisconsin deer-hunting license.

Hunters must possess a valid Sandhill Wildlife Area hunting permit to enter the grounds for the Nov. 10 hunt. Each successful applicant will receive one bonus antlerless permit, valid only within the Sandhill Wildlife area for the weekend indicated on the permit.

The Democratic State Treasurer's race in the Town of Milton Wards 2-4 and the Republican Secretary of State's race in the City of Janesville Ward 21 were randomly selected for the audits. Marc Granger, Milton Clerk, and Dave Godek, Janesville Clerk, were present and the results of the audits matched the Election Day results exactly.

Post-Election audits during the Board of Canvass are optional. Audits have occurred in past Rock County canvasses with no change in results. As public concerns about election interference increases, Lisa Tollefson, Rock County Clerk, has instituted audits as a standard practice and additional safeguard in election security. Making post-election audits a standard practice is recommended by the Defending Digital Democracy Project from Harvard University's Belfer Center for Science and International Affairs. The Wisconsin Election Commission completes the final certification of results for federal and state offices.

RECAP garden holds annual open house

Rock County Education and Criminal Addictions Program (RECAP) garden hosted its annual open house last week.

RECAP garden, sponsored through the Rock County Sheriff's Office, provides educational services to the community and is currently in its 26th year of operation. RECAP participates in providing produce to local food pantries and non-profit organizations throughout Rock County. RECAP inmates put in thousands of hours each year tending to and harvesting produce from the garden. This year alone, 2,913 hours have been spent tending the garden. The garden program is 5 months long and is part of a community service program.

Features of the garden include raised beds, horizontal grows, an herb garden, a natural shelter and a high tunnel.

Sgt. Jay Williams supervises the RECAP program.

"We partner with Blackhawk Technical College for the educational portion of the program to include parenting, computer literacy, employability, and GED/HSED classes," Williams stated in a RECAP press release.

"There is anger management and restorative justice programming, as well as AODA sessions and a cognitive program called Thinking 4 Change."

RECAP offers an in-house counselor who provides one-on-one counseling to the participants.

The garden is located to the east of the Rock County Sheriff's Office off Highway 14 (behind and next to the Youth Services Center). RECAP participants hosted tours of the garden, and refreshments were served.

The market was open, and produce from the garden was available to the public during the open house. Proceeds from the market donations will go directly toward operational costs and future projects in the garden.
